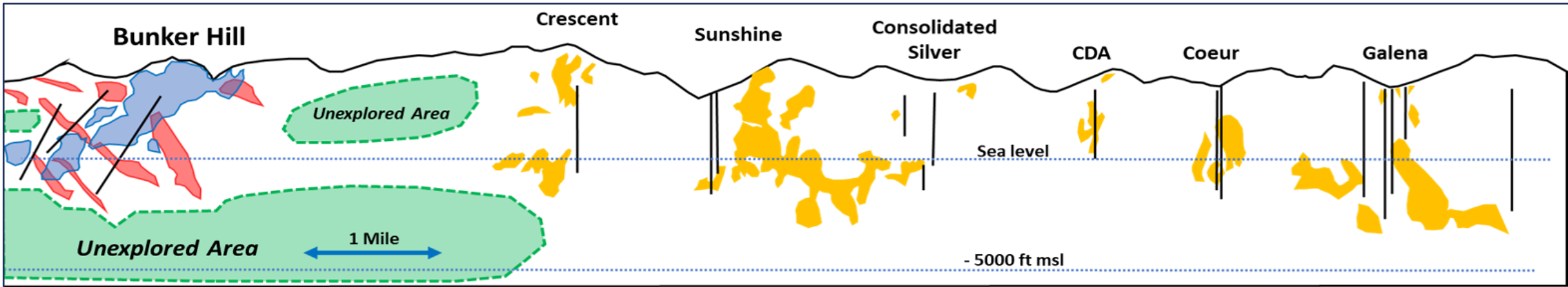

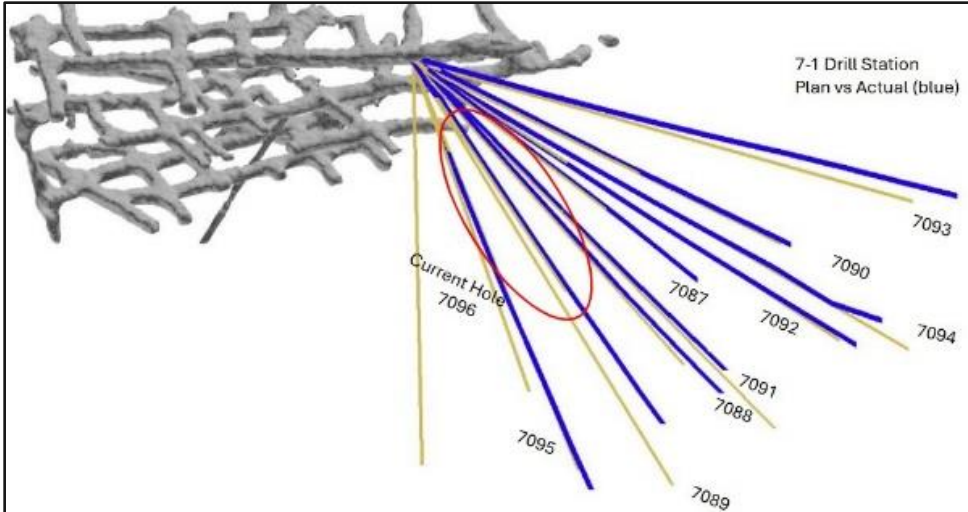

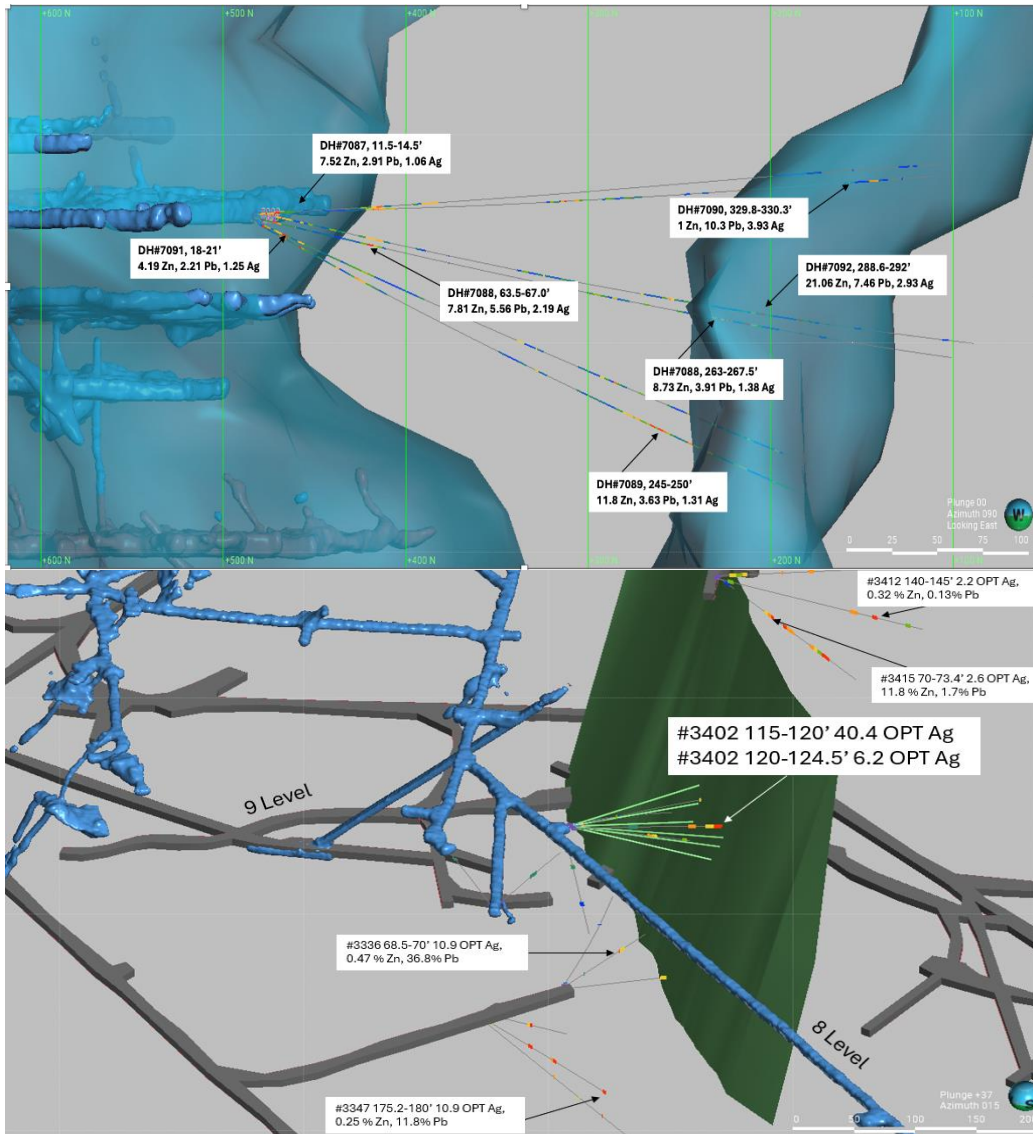

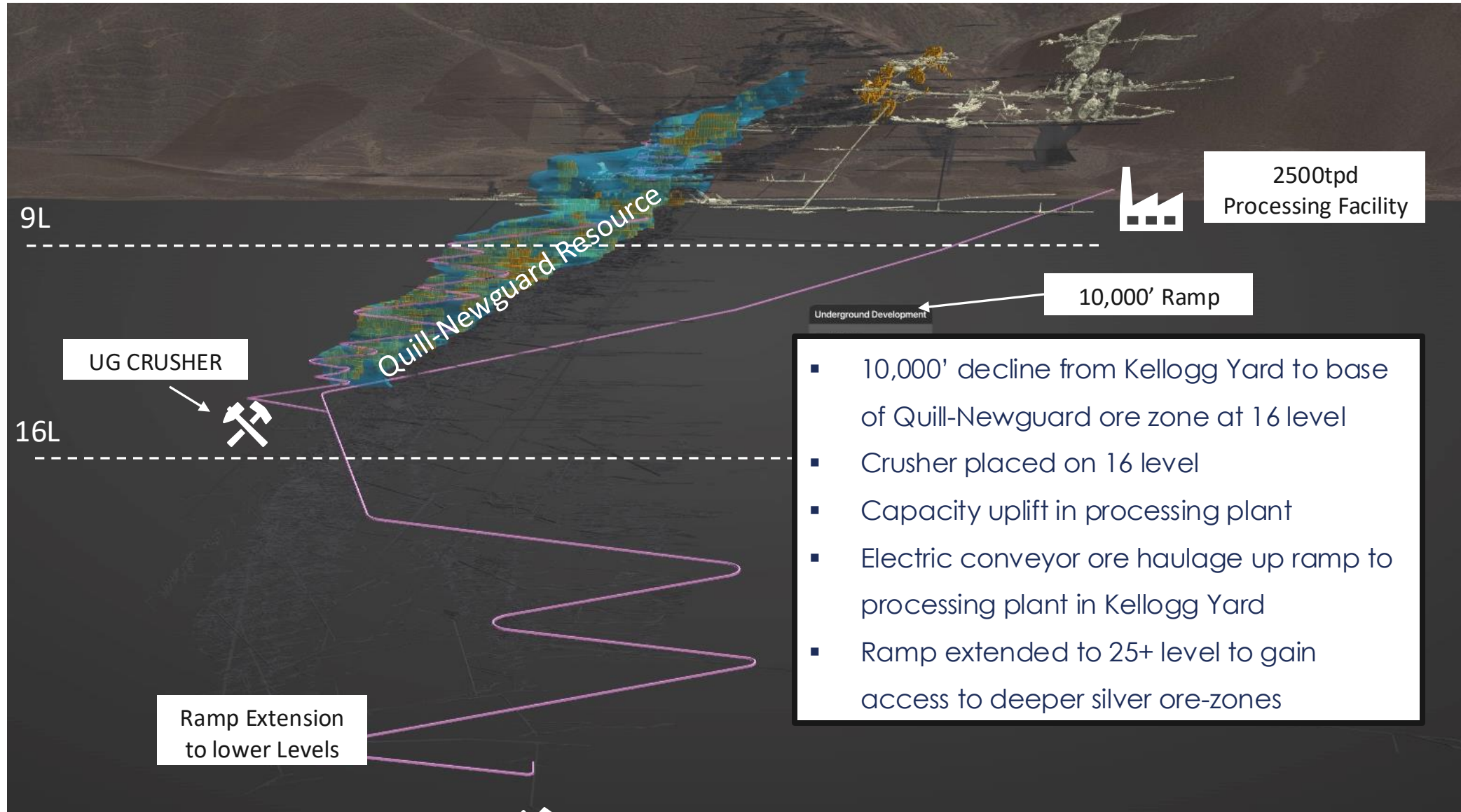
EXPLORATION POTENTIAL

- Resource conversion drill campaign was completed in Q4 | 24
- Polymetallic zinc, lead, and silver mineralization has been intersected in all 14 diamond drill holes completed to date, the results of which will be used to convert Inferred mineralization to a higher confidence category supporting an updated resource and reserve statement in 2025
- A bonanza-grade exploration target with the potential to add several million ounces of high-grade silver resource has been identified adjacent to existing workings on the 8 level, and a second drill program to commence later this year

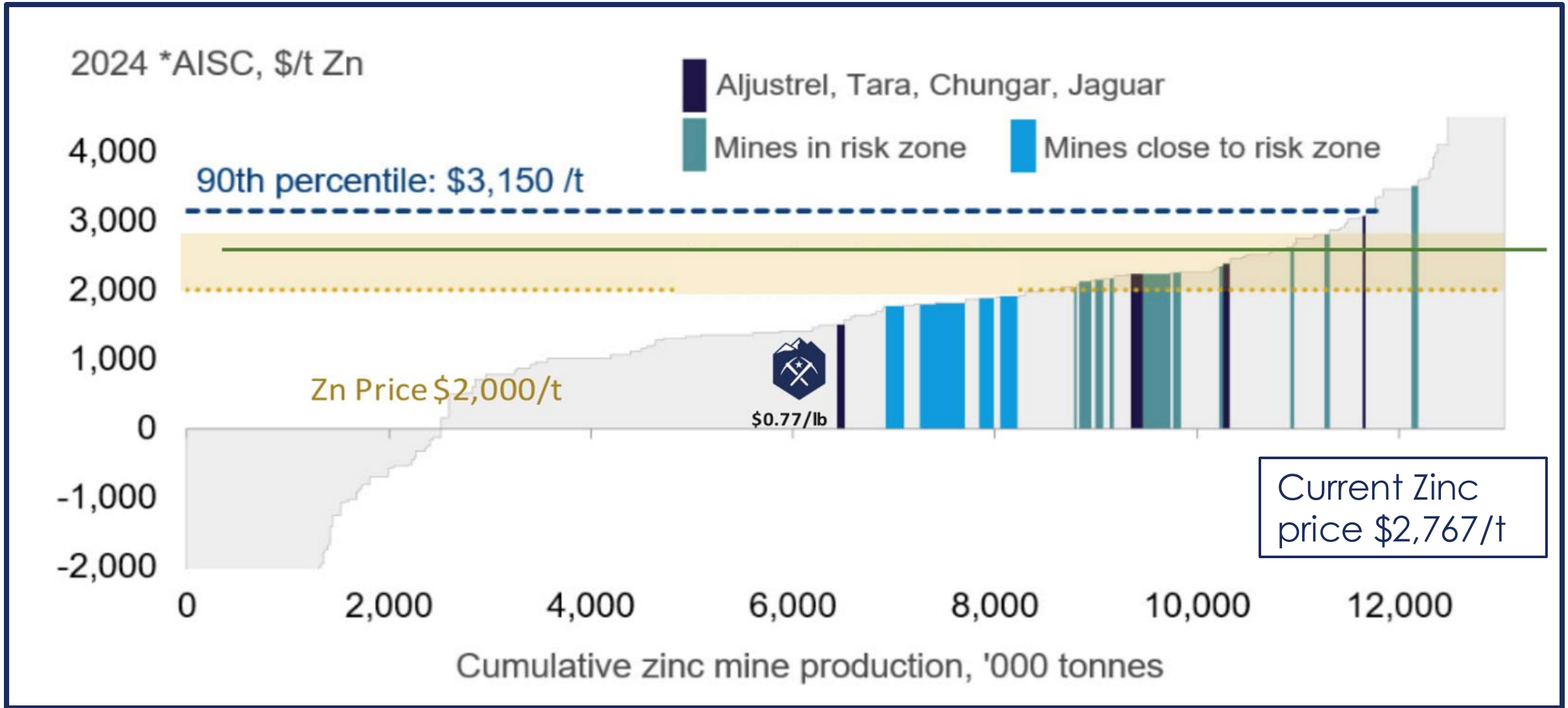
